Within the framework and scope of further development of economic relations between the Kingdom of Bahrain and the City of Nuremberg, Federal Republic of Germany, a visit by Dr. Roland Fleck, Deputy Mayor of the City of Nuremberg and Councillor for Economic Affairs to the Kingdom of Bahrain from 19th April to 24th April 2006 will take place whereby the following understanding will be reached.

MOIC and **SNW** shall collectively be referred as the „Parties“:


- 1) This Letter of Intent outlines the basic philosophy and the framework and scope of cooperation between the Parties, which shall at all times be based on good faith and mutual trust. The principal objective for this Letter of Intent is that both Parties shall join hands in the development of commercial and industrial activities between them and to promote business development and exchange of information, know-how and technology between the economic subjects related to both Parties. The Parties will agree to a period of three years for the Letter of Intent which will run from 22nd April 2006 to 22nd April 2009 and may be extended at anytime by mutual agreement between the Parties.
- 2) Both Parties confirm their objective to strengthen the economic relations and to promote bilateral trade and exchange of information, know-how and technology between the Kingdom of Bahrain and the City of Nuremberg in particular to develop the co-operation between all relevant organizations, i.e. Convention and Exhibition Centres, Chambers of Commerce & Industry, Industry and Trade Associations, Professional Societies, etc.
- 3) Both Parties will support the development of a co-operation between the Ministry of Industry and Commerce, Kingdom of Bahrain and the City of Nuremberg and promote the participation in events, conferences, congresses and exhibitions that are supported or organized by both organizations provided that the events are in line with the principles, strategic targets.
- 4) The Ministry of Industry and Commerce will provide active support such as market information, contacts and marketing support for all companies and exhibitors from the City and Metropolitan Region of Nuremberg who are interested to participate in

international exhibitions and conferences held in the Kingdom of Bahrain to gain access to the markets in the Middle East and in particular the countries belonging to the Gulf Cooperation Council (GCC).


- 5) Each Party will nominate two representatives who will be directly responsible for the establishment and development of the cooperation between the Parties including the preparation of a joint Annual Summary Report.
- 6) This Letter of Intent is prepared in Arabic and English language with one signed original for each Party.
